Item 8.01. Other Events.

On August 29, 2011, Wilmington Trust Company, the Trustee (the "Trustee") under the Indenture, dated September 28, 2005 (the "Indenture"), governing GameStop Corp.'s 8% Senior Notes due 2012 (the "Notes"), at the direction of GameStop Corp. (the "Company"), gave notice to the holders of the Notes that on October 1, 2011 (the "Redemption Date"), the Company will redeem a portion of the Notes remaining outstanding, in an aggregate principal amount of \$125 million, pursuant to the Indenture's optional redemption provisions. Pursuant to the Indenture, the Trustee will select the Notes to be redeemed (the "Redeemed Notes") on a pro rata basis or in accordance with any other method the Trustee considers fair and appropriate. The redemption price for the Redeemed Notes will be 100% of the principal amount plus all accrued and unpaid interest to the Redemption Date.
